You are turning age 65 in the next three months or are already age 65 or older; AND your income is below 120% of the Federal Poverty Level (based on the household size for a single individual or married couple), or is at or below the applicable Medicaid Standard, then the Medicaid program will pay or reimburse you the cost of your Medicare premiums.

The amount of income a person can have is quite high, up to \$2,130 a month in 2013. That is three times higher than the amount of income a person can have (\$710 a month in 2013) and be eligible for Medicaid because he or she is receiving SSI benefits.

Eligibility is determined for Medicaid first, then CHIP using the 5% FPL disregard.
