In 1999, the European Association of Euro-Pharmaceutical Companies (EAEPC) lodged a complaint with the Commission concerning GSK's dual-pricing policy, requesting that the Commission refuse to grant GSK the negative clearance or exemption it sought. In 2001, the Commission found that GSK's system infringed competition law.

The European General Court ("GC") dismissed on 26 September 2018 a 1999 complaint filed by EAEPC, the industry association of parallel traders in medicines, that had urged the European Commission (the "Commission") to resume its investigation of a "dual pricing" scheme operated by GlaxoSmithKline ("GSK") in Spain.

About EAEPC

The EAEPC has joined forces with about 15 other associations concerned over the future of the European Commission's pharmaceutical package, including Association internationale de la mutualite (AIM) and Health Action International (HAI), and has decided to send a letter to the President of the Commission, Jose Manuel Barroso, and EU Health Commissioner Androula Vassiliou, so that Vassiliou is given direct competence over the dossier.

In that context, EAEPC (among others) filed a complaint to the Commission in 1999. Then, the Commission adopted in 2001 a decision, 1 by which it declared that GSK had infringed Article 101 (1), refused granting GSK the requested exemption under Article 101 (3) and ordered GSK to end the infringement.

The EEOC issued sections II (A) and (C) of MD-715, requiring model EEO programs to issue establish written polices and procedures for addressing harassment in the workplace. The legal authority for this requirement was established by the Supreme Court in two decisions concerning harassment liability, Burlington Industries v.
