The United States Senate Caucus on International Narcotics Control was established on August 16, 1985 by the Foreign Relations Authorization Act for Fiscal Years 1986 and 1987 and was originally called the United States Commission on International Narcotics Control. Pursuant to the Legislative Branch Appropriations Act of 1986, the name of the Commission was changed to the United States Senate Caucus on International Narcotics Control, effective November 13, 1985.
